1. Participants must obey all state fishing regulations.

3. Fish must be caught by legal methods during legally open season and taken from unrestricted waters.
4. All claims of record-breaking fish must be verified and officiated using the appropriate application procedures established by the state government game & fish department in that state.
5. A "combined-catch" must contain only the appropriate species as designated above and must be verified by a state government marine biologist. The catch must be caught, presented and officially weighed by contest authorities during the contest period designated above.
6. Tagged fish will be tagged and released by state government game & fish department employee only. The Named Insured and state official shall be the only persons with access to the location and time of the fish release.
7. Anyone related to or employed by the sponsor or related to the person releasing the fish is not eligible to enter the contest.
8. All fish whether tagged, possibly record breaking or combine catch to be weighed, must caught and brought to contest officials during the established contest period to claim the prize.
9. A tagged fish must be recognized as the officially tagged fish by contest officials and/or the tagging representative from the state game & fish agency.
10. The tagged fish must be alive when brought to contest headquarters to collect the prize.
11. All participants must be registered for the contest to be eligible to collect the prize.

Signing of this application does not bind the insurer to complete the insurance but it is agreed that this form shall be made part of the contract should a policy be issued.
